Mike,



You are correct. Chapter 12.68 is the correct part of the Municipal Code that we are using. Specifically, Section 12.68.030(D) is one of seven criteria for the City Council to consider in making the one required finding provided in Section 12.68.020. The City has used the one advisory ballot per unit approach to measure resident support (or not) in the past to avoid potential irregularities. There is no other provision in the Municipal Code or other adopted policy to implement this process and your point is well put. The Code does use the term “residents” not residences. If you want, go ahead and submit a ballot for each resident in the household.
